1. Welcome: Kurt Boniecki welcomed members and guests and thanked them for their attendance.

(OARS) as a way to assist faculty in providing appropriate and timely accommodations to students. Kurt Boniecki will reach out to the Vice President for Student Affairs, OARS, CETAL, and Legal Counsel regarding this concern and a future group discussion.

- b. Instructional Continuity during Inclement Weather Events: Jonathan Glenn shared language that has been developed regarding instructional continuity during inclement weather events. The information will be an administrative policy and will be distributed to faculty at the beginning of each semester.
